Samish Neighborhood Meeting – Proposed Zoning Change

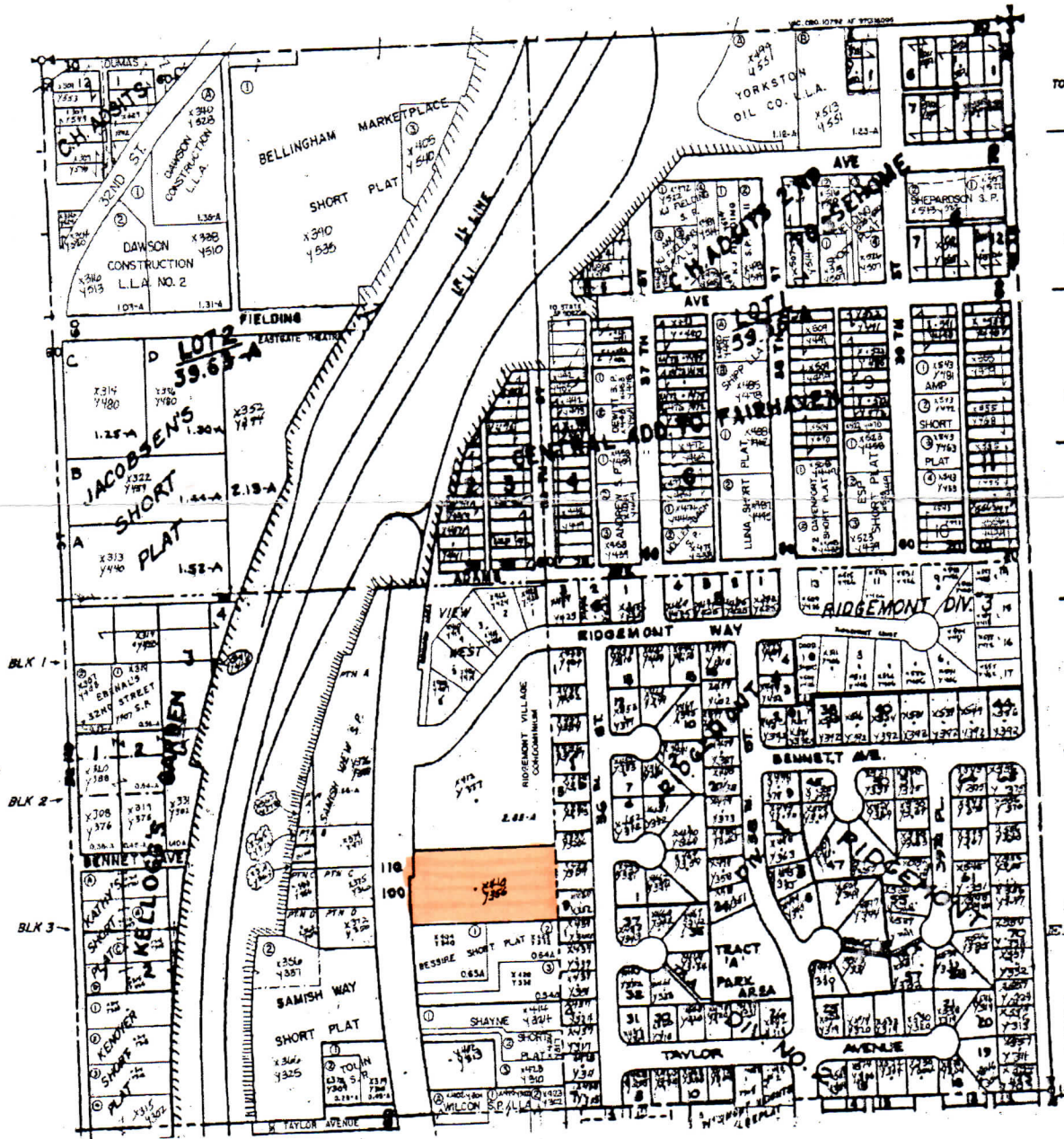

PUBLIC HEARING:

- **ZON2014-00007:** A public hearing to consider amendments to the Samish Neighborhood Plan and Bellingham Municipal Code to rezone Area 9 in the Samish neighborhood from Planned, Commercial, non-retail to Planned, Commercial. Area 9 is located on Samish Way, south of the Elks Lodge (710 Samish Way) and north of the Community Baptist Church (810 Samish Way).

There will be an opportunity for public testimony at the hearing, and written comments should be submitted no later than **November 18, 2014** for consideration at the meeting. All comments submitted prior to or at the hearing will become part of the written record.

After the public hearing is held, the Planning Commission will make their recommendation on the above proposal to the City Council. The City Council will hold a subsequent public hearing to consider that recommendation, and a separate notice detailing the date and time will be sent out at least 30 days in advance.
